- Provide valid explanations the reasons behind different depths of integration in both unions
- Grasp the legal structure of both unions
- Acquire in-depth knowledge of the major foreign partners of both unions
- Be familiar with the EU customs regulations and the Customs Code of the EEU
- Make an informed analysis of economic advantages and disadvantages of Armenia's choice to join the EEU
