It is compulsory part of the MA in European Studies curriculum; additionally it is offered as optional course for international relations, law and sociology students. A module on migration is taught for the first time frames in the of the MA in European Studies. The module is result of interdepartmental cooperation of YSU's departments. It is multidisciplinary in its structure and approach. MPEC is divided into three parts where each is designed or modified to meet general objective of the module and the curriculum, syllabus structure, identification of learning outcomes, etc. The courses are taught by four professors from different departments (law, political science, linguistics, Centre for European Studies) of the Yerevan State University. Each professor has different backgrounds diverse teaching/learning methods: and uses • Course 1. Multiculturalism, identity and values (course was modified on the bases of "Introduction to integration. Cultural perspective"/ European team teaching) • Course 2. Legal regulation of the migration processes and asylum issues in the EU and the RA (new course)

• Course 3. Project Short Description:

The established network for Developing the European Studies in Caucasus has enhanced the level of EU studies in the Caucasus and contributed to development of all consortium partners. The scholarly Association for European Studies in Caucasus (AESC) has been founded by the network as a non-entrepreneurial (non-commercial) legal entity under Georgian law. According to its statute, AESC supports science and research, general political education as well as crossborder co-operation in the countries of the wider Caucasus (Armenia, Azerbaijan, Georgia, Russian Federation, Turkey) and the other neighbouring countries.

 AESC has 96 registered members as to date, from a number of organizations, including but not limited to various academic institutions, e.g. NGOs, Ministry of Labour and Social Protection of Population of the Republic European Studies Association of Azerbaijan, Community Moldova, Office of Ombudsman Georgia, Ecorys Polska, and others. •AESC, as a main project outcome, has initiated the dialogue between policy makers and academia, fostered professional and academic exchange between member institutions under other initiatives and collaborations, including Erasmus+, Horizon2020, etc., has received further funding to ensure its sustainability and implement upcoming activities General activities of the network have been divided into three areas: teaching, research enhancement, outreach. Activities of the network have been successfully implemented as in line with the project application. Most of the consortium partners have (fully or mostly, with some minor deviations) achieved their objectives and technical goals. In teaching:

•Bilateral extracurricular activities such as summer and winter schools and young researchers' seminars have brought together 182 advanced BA, MA and PhD students during 9 teaching events throughout 3 researchers' seminars were organized to train PhD students years. Young in cutting-edge teaching and research methodologies. •Exchange on best practices in teaching EU studies has been achieved with developing teaching materials as schools and seminars proceedings. The scholarly research on teaching politically sensitive issues in multicultural environments have been initiated within the consortium and likely to develop into the peerreviewed academic publication.

In research enhancement:

The initial idea of establishing the WEJLP has been substituted by launching of AESC working papers series. Launch of AESC working papers series has enhanced the research capacities in the target countries in order to create publishing opportunities for young researchers.
Additionally, AESC working papers concept has been upgraded into a Yearbook concept as an extra deliverable to bring additional value to the association. The 1st Yearbook, based on proceedings of 1st

and 2nd AESC conventions, has a tentative title "Europe in the Caucasus, Caucasus in Europe: Bridging Academic and Political Gaps" (to be published by ibidem Verlag in 2019) was presented by authors during the final consortium meeting in Tbilisi in October 2018.

In outreach:

2 annual scholarly AESC conventions were organized in 2017 and 2018 to promote knowledge of EU studies, bring scholarly community together and give the floor to young researchers to present their research. The abstract booklets from the conventions had been published electronically.
DESCnet and AESC webpages, social media accounts and mailing lists had been created to reach more than 400 subscribers.

The corporate design has been created for both DESCnet and AESC to ensure visibility, strengthen identity and recognition during dissemination campaigns and events.
Joint DESCnet/AESC newsletter had been created and 11 editions have been issued and disseminated during the course of the project.

•4 DESCnet consortium meetings and 2 meetings of AESC association members were held during the project lifetime.
